

## QUAIL CREEK PERFORMING ARTS GUILD

Minutes of the QCPAG General Meeting of January 28, 2020

**Board members present:** Cyndy Gierada, Davey Jones, Paul White, Sydney Ranney, Fay Shapiro, Dodie Prescott, Sandy Boyer, Sandy Haegele and Diana Paul.

**President Cyndy Gierada:** Cyndy called the meeting to order at 3:00 p.m. Sandy Boyer stated that the December minutes had been reviewed, approved and posted to the PAG website.

**Treasurer Sydney Ranney:** Sydney reported a balance of \$13,621.42 with \$2,496.73 in reserve. She also said the Christmas Show profit was \$370.00.

Sydney said there are 56 vendors plus 10 non-profits signed up for the Expo which will be held on Saturday, February 8. Sydney asked for volunteers to help at the Expo and reminded membership how important it is to attend the Expo so vendors will return next year. She told membership that it has been more difficult to recruit vendors this year and she would like someone to help her coordinate it next year. She also asked for volunteers to contact local businesses to post flyers publicizing the Business Expo.

Sydney told membership that her term as Treasurer ends in June and she will not run again. She said she is open to continuing to do the bookkeeping but the new treasurer would be required to attend monthly meetings, sign and post checks, etc.

The completed audit was performed by PAG members Nancy Jacobs and Gordon Noraine who submitted it to the Board for periods of 8/6/2018 – 12/31/2018 and 1/3/2019 – 6/14/2019.

**Membership Chair, Fay Shapiro:** Fay announced that seventy members have paid their dues for 2019-20. Fay also told membership that PAG will have a table at the “Discover Quail Creek” event in the Clubhouse on February 7<sup>th</sup> and that Cyndy and Sandy Haegele would attend with the PAG poster, scrapbooks and membership forms

**Publicity, Dodie Prescott:** Dodie reported that she is focusing publicity efforts on “Chocolate, Champagne and Jazz” and “Rumors”, the Spring Play. Additional efforts include the Business Expo with three “What’s Happening” announcements submitted for the coming week. A February article in the QC Crossing will feature an article about the Play and a photo of the “Rumors” cast.

**VP Variety/Music, Paul White:** Paul reported that he will have information next month about the 2020 Christmas Show.

Cyndy reported that the Chorus has prepared seven songs and will perform at the Easter Brunch held in Quail Creek. She also said she is looking for additional instrumentalists for the “Chocolate, Champagne and Jazz” show on June 28th.

**VP Comedy/Drama, Davey Jones:** Davey said that the dates for “Rumors”, the Spring Play, are Thursday, Friday, and Saturday, April 9, 10, 11. The cast has been selected and he asked them to stand. Seating will be cabaret style with tables of 8. This year PAG will sell the tickets and the price is \$17.50.
